Reverend Eitaro Hayashi, our Representatives, and all Hawai'i News Networks —

Scott Goold and I met with Reverend Hayahi in person 3 days ago at the Shinnyo En Temple in Honolulu and he stated that he would get back to us. Has anyone discussed our request with the Floating Lantern Festival Committee? Did anyone speak with the lead planner in Japan, Atsushi Matasunaga? We explained that we have been ignored for 5 years. Shinnyo En Hawaii continues to ghost us.

Her Holiness Shinso Ito claims commitment in the beliefs that spiritual traditions and practices can help foster peace and understanding in the world; and Her Holiness travels the world cultivating harmony between cultures and religions. We deeply admire her efforts and are motivated by her words. However, the Shinnyo-en Hawai'i are NOT following those principles.

Unfortunately, the words of Her Holiness are not harmoniously aligned with the actions of Shinnyo-en Hawai'i. Our only request is that the beautiful ceremony of Shinnyo Lantern Floating Hawai'i is held on Sunday (or Saturday), and leaves the sacred observation of the sacrifice of our American comrades for Monday — Memorial Day. Their touching event tramples on the memory of those who gave their lives for ALL our freedom. They have no voice. We must speak for and defend our national heroes now in return.

Shifting to Saturday or Sunday from Monday will not only resolve this conflict, but increase attendance. Participants have expressed Monday evening is difficult. Families must return to work or school early the next day. Costs are higher both for you and the city and state due to the overtime spent on the holiday. Your current date also prevents many of our military families from attending our to other Memorial Day ceremonies and activities.

We truly hope Her Holiness Shinso Ito will respect our sacred observation and wish to avoid unpleasantness or further conflict. Our Veteran groups are not appreciative. During the Christmas holiday, we rallied over 5,000+ roaring motorcycles to parade through Waikiki to raise funds for our Toys 4 Tots program. Hawaii's Veterans LOVE our keiki. Imagine their love for their fallen mothers and fathers, sisters and brothers, uncles, aunts and cousins. We believe, if necessary, that we will rally a group far larger if we cannot reach peaceful, harmonious compromise.

We all win by working together cooperatively, peacefully and harmoniously ... the stated values of Shinnyo-en Hawai'i.

We are losing our patience. We have tried for 5 years and your organization continues to blow us off. There are over 250,000 Veterans and Active Duty in Hawaii, Shinnyo-En is trampling on a National Day set aside to honor our fallen.

Scott and I will be addressing the Oahu Veterans Council and all the Veteran Service Organizations this Saturday at 9am. Based on that discussion, we are going to the press and our elected leaders to bring this conflict out in the open. We don't want to do that, we would like you to just move your event one or two days to the left (still over Memorial Day weekend, not on Memorial Day).

I will also be attending the Mayor and Governor's Memorial Day ceremonies at Punchbowl and Veterans State Cemetery, and I will be sure to discuss this topic with both of them.

Thank you for your email. We appreciate your continued interest in Shinnyo Lantern Floating Hawai'i and we appreciate your thoughts and suggestions.

Nearly 50,000 residents and visitors participate in the ceremony, including members of the U.S. military, their families and leadership across all branches of the military represented in Hawaii. And floating a lantern on Memorial Day is another way to remember and honor those who have fallen in service to our country.
