

Special Forces Association President LtCol (Ret) Pete Tingstrom Publicly Humiliates Scott Goold

Although Scott Goold served military service in limited capacity, Scott is not a current military member. Scott arrived on O'ahu 2018 from the small town environment of Kaua'i. Scott was shocked how O'ahu city folks treated the valiant men and women on Memorial Day. As a private citizen, Scott began a political campaign to restore the respect our national heroes deserve on this hallowed day. Scott teamed with numerous citizens and military members over a five year period.

Scott connected with Special Forces Association (SFA) president LtCol (Ret) Pete Tingstrom after their 2023 efforts. Pete told Scott he agreed Shinnyo-en was trampling on the solemn observation and expressed interest in assisting. Scott and Pete teamed up for the 2024 political action. As Scott had pushed Shinnyo-en and local officials forcefully, based on information and belief, Scott claims that he and Pete agreed to a strategy where Scott would continue a "Bad Cop" role to create a sense of urgency, and Pete would play "Good Cop" to motivate officials to modify policy.

As progress had stalled, Scott politely called for the resignation of the president of O'ahu Veterans Council on May 15, 2024, which Scott sent to his personal list serve of recipients, including Pete:

At this time, BoycottShinnyo.com humbly requests the immediate resignation of Honorable COL. Edward R. Cruickshank, president of O'ahu Veterans Council and Center. This polite request is not made to disparage COL. Cruickshank or diminish his outstanding work. Our world is changing. OVC must change with the times ... (Attached below)

SFA president LtCol (Ret) Pete Tingstrom apparently was offended. Pete did not speak to Scott directly. The SFA president hijacked Scott's email list and publicly shamed and humiliated Scott. Scott was blindsided and felt betrayed by his partner. Scott told Pete that his negative comments divided their efforts, and likely would lead to failure in their collaboration.

As SFA president LtCol (Ret) Pete Tingstrom published his comments publicly, without notifying Scott or discussing his concerns with Scott, Scott shares this history as part of the project history.

Scott —

These kinds of e-mails are not necessary and don't help your campaign/end state. I agree with what you are trying to do, but not the way you are going about it. I must speak up.

Consider this...

You have been working this for 5 years and no one has responded to you. Probably due to the language and tone in your e-mails.

I just started working on this project this year. I agree with the end state, just not the way you are going about it.

Consider this...

1. I talked to Parks and Rec Permitting Division - Even if Shinnyo En agreed with us and tried to move their event THIS YEAR to Sat or Sun, they cannot due to other events. I've asked. So my goal is to get Shinnyo En to change for next year. I want their commitment to this before 27 MAY.
2. I reached out to SEN Gabbard - he responded and is still working with me. I reached out to many others, but without a response. I will continue to work this.
3. It was my idea to meet the Reverend at Shinnyo En Temple - and I e-mailed him often...and he finally responded to me. However, has not responded since. Sounds like I have to go back down there again.
4. I contacted KHON, they are discussing the topic with their Editorial Team - they responded to me. Still working this.
5. I reached out the Mayors office and the Chief of Staff has responded to me 8 times with updates. Still working this, I am providing talking points to reengage with the Mayor.

6. I reached out to JAVA - they responded to me as well...and I'm still working the issue through Lynn in the background.

7. I reached out to the Japanese Consulate - they responded...and have a two prong approach to deal with them....The Mayor's Office and JAVA.

8. I reached out to the Governor's Office - they responded...just stated they are too busy to take a meeting with me.

8. I reached out the Oahu Veterans Council and the 40 VSOs they support. I am in constant dialogue with them as well. We are still coming up with options that would work, not alienate others.

I am not going to embarrass myself, our Veterans, or Veteran Organizations. There are ways to go about this without sending e-mails out like you did below and have done in the past calling people out for their failures to support our fallen. Again, I agree with why you are doing this, just not the way you are going about it. You will not get "change" the way you are pursuing this. I thank you for the website you put together, some fantastic information in there. I would just recommend taking out the "Imperial" Japan comments and clean it up to just educate.

I have Veterans who are willing to go to the Floating Lantern Festival (during the prep phase on Memorial Day) and talk to people about this. We plan to have them sign a petition asking Shinnyo En to move the ceremony next year to Saturday. I invite you to join us at Ala Moana Park (after the Governor's ceremony). I will likely be down there around 3pm to get people to sign our petition. The goal is NOT to interrupt their event this year, but to educate and gather signatures. All I am attempting to do is show Shinnyo En the number of people and organizations that support them moving it to Saturday next year.

Lastly, if I don't get any commitment from Shinnyo En by Memorial Day to change the event next year. I have already started preparing a permit for a Veteran Memorial Event next year the evening of Memorial Day (nothing like what Shinnyo does). I will get the permit in to the Parks & Rec before Shinnyo En does. It will then be up to the Mayor's Office to select which permit they will support. Normally it is first come, first served. However, due this organization doing it for 25 years, this will be elevated to the Mayor's office for decision. I'm not worried though, as I believe we will have support from the Mayor and Shinnyo En can then change their permit for Saturday May 24, 2025 in the evening. We don't want them to compete with Memorial Day or the Memorial Day parade either.

Memorial Day Events this year:

26 MAY (Sun)

10 am Memorial Day Ceremony at Natatorium - American Legion & Friends of the Natatorium with the Motorcycle Community (mostly Veteran clubs)

5 pm ALL ARE WELCOME - Hawaii Memorial Day Parade in Honolulu (Marching, military bands, scouts, military units, and veterans march from Fort DeRussy, Waikiki, down Kalakaua Avenue, then Monsarrat Avenue to the Waikiki Shell. The parade starts at 5 p.m. with a memorial ceremony and is followed by an evening concert afterward.

27 MAY (Mon) Memorial Day

8:30 am Mayor Rick Blangiardi of the City and County of Honolulu will hold a Memorial Day Ceremony at the National Memorial Cemetery of the Pacific (Punchbowl).

1 pm Governor Josh Green of the State of Hawaii and the Office of Veterans' Services have a Memorial Day Ceremony at the Hawaii State Veterans' Cemetery in Kaneohe

I will be attending 100% of these events and encourage others to do the same.

RE: BOYCOTT Shinnyo-en Calls for Col. Cruickshank to Resign

Aloha e COL. Cruickshank ~

Yesterday, in my letter to you and public officials, nicknamed you, *Col. Bare Minimum Cruickshank*. Did so to make a point. Do not wish to be disrespectful to you, your heroic service to our nation or the outstanding work you have done for Veterans. I do however need to emphasize what you said in your moving *Story of Valor*, “because you become like brothers. And you will do anything you can to save that individual from being hurt even if it means putting your life at stake.”

You are not doing everything you can for the over 53,000+ valiant, fallen brothers and sisters resting at Punchbowl. OVC is not. Our local ‘Ohana is not. As a community, we have collectively failed our heroes. They sacrificed ALL. We have responded by weakly and nonchalantly giving some. It is time for change.

Therefore, with the utmost admiration for your efforts and service over a lifetime, humbly ask you to step down immediately from your leadership position as President of the O’ahu Veterans Council and Center. I do not seek your excellent record to be stained or shaded. Rather, consider this request like the USA Olympic 1600M Relay Team heading to Paris 2024.

You have run a remarkable leg. Now I ask you to pass the baton to the next runner. We need the energy and commitment of team runner #2 at this time; as this team runner will soon pass the baton to team runner #3. Our line and corp is strong. Energy and motivation must remain strong. The observation of our fallen heroes has become tired.

Please step down with distinction. I submit my name to receive the baton from you. You have created the framework for an outstanding organization. Was quite nervous when I spoke to the group Saturday, April 27th. As I mentioned, was humbled being around so many heroes. I am in awe of all the accomplishments and devotion to this nation, state and Veterans from each of you. The group nevertheless has low energy. Veterans need a cheerleader.

OVC demands an infusion of new thinking and life. Times have changed. Parades down Main Street, politicians gathering at Punchbowl or Veterans Cemetery in Kaneohe do not inspire the current and next generations. As noted on BoycottShinnyo.com website, even Buddhists are modifying their presentation to become “more cool” to younger generations. OVC must seek to be *more cool* as well. We live in a competitive entertainment world.

The sole objection to Shinnyo-en Floating Lantern is their day of observation. This day, the entire day, is dedicated to honor our nation’s fallen heroes in uniform; not civilians. We must hold the line.

At this time, as a candidate for OVC president, I propose the organization host **Lantern Lighting Punchbowl** next year on Monday, May 26, 2025. As OVC president, my first act will be to request LtCol (Ret) Pete Tingstrom serve as Chief of Staff. Pete's qualifications are impeccable:

My PhD work at the University of New Mexico focused on political science and policy. Served Workers' Compensation as an advanced economist and policy analyst. My legal skills are top notch. Ask Hawaiian Electric. I'm a trained specialist advocating to keep citizens and Veterans off dangerous, addictive opioid medications. Too many Veterans suffer.

I've championed the efforts of Hawaii's U.S. Senator Brian Schatz for years. His team reports lack of medical cannabis kills our Veterans. The federal government recently announced their intent to reclassify medical cannabis to Schedule III from Schedule I. Research will explode. Many local corporations deny our Veterans employment due to their medications. We must evolve.

Have a warm relationship with Governor Josh Green, MD. Pete has established strong ties with Mayor Blangiardi's office. You will be passing the baton to competent professionals who love our Veterans and country.

Lantern Lighting Punchbowl

CoS Pete Tingstrom's first assignment will be to procure a city permit to host an OVC event in Ala Moana Park on Monday, May 26, 2025. We will graciously invite Shinnyo-en to continue their heart-warming **Floating Lantern Hawai'i** on Sunday, May 25, 2025. We will do what no community in the USA has done — create **Memorial Weekend**. Our objective will be to assist Shinnyo-en attract some 50,000+ on Sunday; while we build our event to host 50,000+ on Monday.

As times are changing across America, we must evolve with change. Decoration Day evolved into Memorial Day. We now suggest Memorial Weekend. In addition, Memorial Day focused on the men and women who died in combat. Our battles to defend our nation and preserve our values are fought by more than solely men and women who wear camo or digis today.

We're still overcoming the brutal suffering the nation and world endured due to SARS-CoV-2. Men and women wearing scrubs served on the front line of this war. **Lantern Lighting Punchbowl** will also honor our nurses, DRs and medical staff who perished in this war against nature.

Our local and national firefighters also wear a uniform to defend this nation and our values. We now are fully aware the heroics of Maui Fire Department. Their team sacrificed homes and family members in their selfless fight to save the historic Lahaina community. Firefighters will be honored.

We also include the heroic men and women who serve in the Thin Blue Line. Our peace / police officers stand in defense heroically each day and night to ensure our values are protected, as well as homes and families. **Lantern Lighting Punchbowl** will honor these fallen heroes as well.

Civilians will be honored on Sunday, May 25, 2025. Those who served and sacrificed in uniform to defend and protect our families, communities and nation will be honored Monday, May 26, 2025.

In the first **Lantern Lighting Punchbowl**, we will dedicate ceremonies to Nisei soldiers. We will seek partnership from the Japanese American Veterans Association. Nisei contributions to Hawai'i and the United States of America have never been fully honored. And, each year going forward, we will highlight a team, squad, company or group of uniformed heroes to lead the proceedings.

We will move beyond the traditional solemn event. A concept Op Order would look like this:

1900: Sikorsky SH-60 Seahawk helicopter will drop a team of 4-5 amphibious SEALs into Ala Moana bay. They will swim to light our anchored signal fire.

1905: SEALs light signal fire

1906: Flyover of F-22 Raptors trailing red, white and blue smoke

1910: Motorcycle Veterans representing mechanized Calvary rev & roar engines — 30 seconds

1911: Fireworks and National Anthem

1915: Lantern Lighting Punchbowl ceremonies begin

The booming engine roar will serve to WAKE our slumbering heroes lying in love at Punchbowl. As told previously, I spent much time in meditation and contemplation on the hallowed grounds. Our brothers and sisters whispered to me softly, "We are so lonely. We are being forgotten." I played my ukulele for them; their spirits danced and sang. They want to live with us.

Lantern Lighting Punchbowl will WAKE our heroes. They will join us for patriotic music, festivities and lantern lighting. As the designated MC calls out names of our highlighted and honored brothers and sisters, food will be served and plates set for our fallen heroes. Toasts will be made with glasses raised and filled for our fallen heroes as well.

We will honor their sacrifice — giving ALL — by inviting our fallen brothers and sisters to sing, dance, eat and toast with all of us. They do not want to lie at rest lonely in silence. They want to be remembered as they lived ... full of life. And be honored for what each gave to us ... their life.

This is the way of a new generation of Americans; citizens who again are AWAKENED to the real human cost of freedom, and the sacrifice of the FEW giving ALL so the MANY can enjoy so much.

Please accept this request in the spirit of aloha, duty and honor. Your leadership has taken OVC to a position of acclaim in our 'Ohana and Veteran community. We ask that you pass the baton so the team can continue the next leg forward on this path to greatness.
